Customer Liability Form for: Returnable Refrigerant Cylinders

This Form sets out the arrangements which will apply to the supply or sale by us of any returnable refrigerant cylinder to you and will take the place of any previous arrangements.

It is a legal contract covering the safe storage and handling between us and you for the supply or sale of any refrigerant. The terms of this liability form applies to each order which you place with us for any returnable refrigerant cylinder(s).

We agree:

- (i) to send you at a specified address full returnable refrigerant cylinder(s) you have requested within any reasonable time scale you have specified subject to any unavoidable delay.
- (ii) to collect at our cost any empty returnable refrigerant cylinder(s) belonging to us, from you, that has been in your possession or under your control for a period of twelve (12) months unless you have notified us in writing that you wish to purchase such refrigerant cylinder in accordance with the provisions below.

You agree, whilst you hold any returnable refrigerant cylinder of ours to:

- (i) ensure its safe keeping and make adequate arrangements to protect the cylinder against loss, misuse or damage due to negligence, fire, theft or vandalism.
- (ii) inform us immediately without delay of any refrigerant cylinder(s) that is lost, stolen or damaged whilst under your control or in your possession.
- (iii) make available for return any returnable refrigerant cylinder(s) to us immediately in its original packaging that has been in your possession or under your control for a period of twelve (12) months unless otherwise agreed.

- (iv) pay to us the purchase price of £75.00, or such other amount as advised to you from time to time, for any cylinder(s) you have received from us that has subsequently been lost, stolen or damaged whilst in your possession or control in accordance with the paragraph above. Autoclimate reserve the right to review and increase this price by notifying you in writing.


Any returnable refrigerant cylinder(s) sent to you by us will remain our sole and absolute property unless otherwise agreed.

Risk of damage to or loss of any returnable refrigerant cylinder(s) will pass to you upon delivery. We shall have no liability to you or your employees agents or customers for death or personal injury (except where liability arises from our negligence or so far as required by law), or for loss or damage to any premises or property stored or kept on them.

If at any time you become insolvent or cease trading we may without liability to you arrange to enter the premises and remove any returnable refrigerant cylinder(s) held by you.

Our agreement regarding the supply or sale of returnable refrigerant cylinder(s) may be ended by either of us giving not less than 30 days notice in writing to the other and the return of all cylinders in your possession.
